Texas Catholic Conference of Bishops Evangelization and Catechesis Department Standard Operating Procedures/Guidelines

Article I – Name

This organization shall be known as the Texas Catholic Conference of Bishops Department of Evangelization and Catechesis (TCCB-EC) of the Texas Catholic Conference.

Article II – Purpose

The purpose of the TCCB-EC is to

Communicate and collaborate among membership and Bishops of Texas Provide an opportunity to address common issues and concerns Provide professional and spiritual development opportunities

Article III – Membership

The work of TCCB-EC is composed of Diocesan Directors of Evangelization and Catechesis and Associate Directors of dioceses in Texas. Associate Directors serve as members but may not serve as Chair.

Article IV – Officers

Section 1. The Executive Committee consists of the Chair, Chair Elect and Secretary.

Section 2. The term for Chair and Chair Elect shall be two years; the term for Secretary is three years.

Article V – Election of Officers

<u>Section 1</u>. Officers are elected at the Mid-Winter meeting (usually held in January). The term of office begins at the conclusion of the meeting at which the election takes place.

Section 2. (Selection of Officers)

Officers shall be discerned by a simple majority of the dioceses present at the meeting.

Diocesan Directors of the TCCB-EC, who have participated in TCCB-EC meetings 2 out of the last 4 meetings, are eligible for the office of Chairperson Elect.

The position or Secretary may be held by a Director or Associate Director.

The Nomination/Election Committee presents nominees and conducts the selection process during the General Meeting.

Article VI – Officers - Duties/Responsibilities

Section 1. Duties of the Chairperson.

Call and chair meetings of the TCCB-EC and of the Executive Committee of the TCCB-EC.

Facilitate communication between members and the Bishops of Texas, their appointed liaison to TCCB-EC and all other appropriate groups.

Represent TCCB-EC in all official relationships with other groups.

Appoint the members of the Nominating Committee (at the September/October meeting) and any ad hoc committees as deemed necessary.

Section 2. Duties of the Chairperson-Elect

Function in all capacities in the absence of the Chairperson

Monitor the progress of all Committees

Perform any function assigned by the Chairperson or the Executive Committee

Section 3. Duties of the Secretary

Take roll call to verify members and voting eligibility and keep minutes of all regular business meetings and distribute copies to the membership

Keep minutes of Executive Committee meetings, send them to the members of the Executive Committee, and make copies available to any TCCB-EC member

Keep a directory of members of TCCB-EC, along with current contact information

Keep a copy of the Operating Procedures of the TCCB-EC and record changes as may be made in the course of time

Perform all other secretarial duties requested by the Chairperson

Article VII – Meetings

<u>Section 1</u>. Regular meetings of the Department shall be held a minimum of two times a year. These meetings are limited to (Arch) Diocesan Directors and Associate Directors of Evangelization and Catechesis, or an acting Diocesan Director of Evangelization and Catechesis designated by the bishop's office of that (arch) diocese. In the event a Diocesan Director of Evangelization and Catechesis is unable to attend, the Diocesan Director of Evangelization and Catechesis may approve a substitute. A Diocesan Director of Evangelization and Catechesis substitute will have full voting rights and responsibilities of the (arch)diocese represented.

Section 2. Special Meetings shall be called when either:

The Chairperson recognizes a need

The Executive Committee makes a request

Upon the written request of a majority of dioceses of the TCCB-EC

Article VIII – Voting

Section 1.

In order to constitute a quorum for a regular or special meeting, three-fifths of the Diocesan Directors of Evangelization and Catechesis must be represented.

Section 1.

The passing of measures is done by simple majority.

Article IX – Committees

Committees shall be created as needed, and members shall be appointed to such committees by the Chairperson.

Article X – Changes

Section 1.

The Operating Procedures shall be reviewed annually at the Mid-Winter Meeting (usually January).

Section 2.

The Operating Procedures can be amended at any regular meeting of the TCCB-EC by a two-thirds vote.

Proposal of New Vision of TCCB-EC

"All Christian formation consists of entering more deeply into the kerygma, which is reflected in and constantly illumines, the work of catechesis..." (Evangelii Gaudium, # 165)

TO THE BISHOPS OF THE STATE OF TEXAS

Having accomplished the goals set forth in January 2011, the TCCB-EC, at their Mid-Winter 2017 meeting, developed a new vision and strategic plan to be implemented over the next 5 years. The hope is that this plan will help to unify the catechetical efforts for the state of Texas, provide an opportunity to share resources with all dioceses, and develop technologies to better implement solid faith formation and evangelization efforts of the 21st Century. We are hoping this vision supports the vision of the Bishops of Texas as the primary catechist of their dioceses for the TCCB-EC.

Background History

At the January 2011 meeting, the Texas Catholic Conference-Religious Education Department developed four goals for the next three to five years. The department presented a proposal to the Bishops of the Texas Catholic Conference for their consideration and input.

The Bishops recommended that TCC-RE work on the following goals:

Create guidelines for the formation of parish catechetical leaders (PCLs) that:

adequately form leaders for the reality of communities that are diverse in many ways;

promote multiple modes of delivery;

lead to reciprocal recognition of formation of PCLs by the various (arch)dioceses of Texas.

Create guidelines for the formation of parish catechists that provide:

a strong Catholic theological foundation;

skills in catechetical methodology.

In response to the recommendation from the bishops, TCC-RE produced two documents at the January 2014 meeting: Guidelines for the Formation of the Parish Catechetical Leader and Guidelines for the Formation of the Parish Catechist. These documents were based on the *National Directory for Catechesis* and the *National Certification Standards for Lay Ecclesial Ministers* created by the Alliance for the Certification of Lay Ecclesial Ministers on Certification and Accreditation. The Bishops of Texas approved both of these documents thus accomplishing 2 of our goals.

New Proposed Vision of the TCCB-EC

This organization (formerly known as the TCC-RE) shall be known as the Texas Catholic Conference of Bishops Department of Evangelization and Catechesis (TCCB-EC).

Having encountered and dedicated our lives to Jesus Christ, we are united in our continuing journey of transformation to serve the Catholic Church of Texas through Evangelization and Catechesis.Embracing the mission of the Texas Catholic Conference of Bishops, we work through the ministry of Evangelization and Catechesis to form and deepen the relationships of others with Jesus Christ.

In solidarity and with greater understanding of the diversity of our dioceses, we build and nurture relationships among diocesan leaders in order to promote spiritual, intellectual, and professional development as a community of leaders with a common mission.

Update from the meeting with Cardinal (By Julie)

As a TCCB-EC, we came up with strategies, a mission and vision. The mission matched the mission of the Bishop. The original mission dealt with accreditation for Catechist, which we have already completed as part of our previous goals. We approached Cardinal DiNardo seeking his advice, wisdom and guidance. He wants us to submit a proposal with the changes of the mission and vision to be voted on at their meeting. Gus sent a copy of the mission to Jennifer from TCCB.

Conversation from proposal sent to Cardinal for TCCB Bishops meeting

Concern: In looking at this, smaller dioceses were not present in our gatherings. The western portion of Texas have not attended most of our gatherings. Two comments regarding proposal for Strategy A: Fine but pretty wordy, is it practical, inspiring and transformative. He wonders if we really going to be able to do as much as we would like to do. Everyone's plates are pretty full and how much of this is really practical? Regarding the portion on mentoring, do we have a plan for how is that going to be actually organized and done on an ongoing bases?

- The TCCB-EC engages in innovative and vibrant professional growth opportunities. Develops and inspires transformative leaders who provide a prophetic witness of the gospel. Develop a process for reciprocal recognition of formation of PCLs by the various (arch) Dioceses of Texas.
 - Gus Opportunity to do professional development as well as spiritual development utilizing an online format like Zoom. Organized monthly by webinar. We invite people to watch and discuss what they have learned. First session was difficult to organize, second session in August, sent Super Chicken TED Talks, talked about structure, and open environment. A few were able to meet for about 45 minutes. Will continue to do it for next month.
 - Cheryl Never received Super Chicken email, didn't receive invitation for Zoom meeting either. Missed a few people.
 - Gus Fine tuned it and see how people were missed. Recognize that there a few that didn't receive it.
 - Cheryl Technology, Formation, and Personal Development were the topics discussed. Each person would provide something in those areas in the year.

<u>Strategy B</u>

Create tangible structures and opportunities to invite and welcome individuals and groups who share the mission of Evangelization and Catechesis. Create a tangible structure and opportunities to support and encourage, challenge and mentor existing members. Create a system of reciprocity to recognize certification of catechists and catechetical leaders in Texas.

- **Brian Update** Working on creating materials, tangible materials to send to Directors and other staff in those dioceses that haven't been as active. Very minimal progress has been made at this point.
- Has anything been done re: reciprocity or certification or centralized efforts or Arch diocese of Texas. Perfect topic for mid-winter meeting in January. Minnesota had a centralized 3 tier system and could explain that at next meeting. Will be added on that strategy team.
- How much effort is put in each diocese religious education program for catechist to have a certificate or certification. Catechist certification is that a requirement? Discussion on certification of catechist.
- Each Diocese handles their own certification program, Bishop has asked that he would like certification to be completed. DRE's are required to be certified. Our diocese have certification programs, but we all have a low percentage of certificated catechist. If there was a central depository to see what are requirements for certification.

- Creating packet brochure. Invitation to others, translation to diocesan leaders in Spanish. Propose adding Beaumont Bryan, letting him be in charge of that.
- Bryan Re: reciprocity, when first came here had central repository of everyone's catechist formation programs and had full reciprocity. Anyone who had the highest level of recognition of any diocese was automatically granted highest level or recognition of any diocese. All information needs to be on website. Cheryl from Dallas thinks that is the better way to go have information posted somewhere. It was kind of determined to by the # of hours, and based on topic areas. If anyone has information about this contact Bryan from Beaumont, please send him information so he is aware of what was done in the past.
- Keep in mind Catholic Schools, formation are used depending on program, so need to be in communication and contact with Catholic School system. Some dioceses takes care of the certification of teachers. That piece needs to be included. Sister Hilda wants to be a part of that.

At the National Level El Paso was with a different Region, not part of Region 10, but would come over. Lubbock, not responding. Luis added that communicating through google groups, TCBEC group, let Juan Carlos know through chat as well if you're getting emails through the TCCB EC group.

Luis added there would have been an email to see who's on there. Went through list and just about everybody was on there. Just a matter of following up, some members are still pending evites. He will add instructions on how to be put on list. Schedule a virtual meeting.

Strategy D – Debbie Teresa and Paul

In an effort to remain connected in prayer, utilize technology and other means of communication. Initiate ways to be in solidarity through prayer within and among (Arch) dioceses. When the TCCB-EC gathers we will reserve time for meaningful prayer that builds community.

Paul –Looked into twitter to use a prayer chain, but didn't have a way to make it private. So decided to use Facebook page, which is already set up. Working on asking other people to do opening and closing prayer for

this meeting. Debbie had created prayer, but asking other people to do that once we know the theme of meeting.

- **Debbie** 3 meetings on video meetings and 3 main things were intercessory prayer for needy, prayer for the meeting and also getting outside sources
- Question about Facebook page, can anybody post to it? Luis responded, "yes". It's a secret group, so only members could see. Present time 16 members, one invited, not yet accepted. Not more than 16. Please send Luis Facebook name to be added or a member could add as well. Would it be possible to send out a most recent survey with contact information for everybody, Luis will do. A lot of changes, a lot of new people, is not complete. Luis will update for midwinter meeting.

Preparation for nomination for Chair elect in our Mid-Winter meeting (Luis)

Since last meeting he has not been able to follow up with anyone of the Religious Education Directors to this area. He looks forward to present at least one nominee in the next few months. In previous gatherings we had discussed experience and years as Directors to be qualifies to be nominees. Our last standard operating procedures indicated that how many meeting they have attended and how long they've been director for the office of chair. It seems to have been in our January 13, 2016 gathering it was decided that diocesan directors who have been members for 2 years and have attended at least 2 out of the last 4 meetings are eligible for the office of chair elect. Before it was 6 meetings for eligibility, but changed it to 2 years 2 meetings as the director. Luis will send out creative form for nominations. Luis will help us understand the system we have for chair elect. So next year after winter meeting, Julie become end her term, Cheryl become chair, and we're electing chair elect. Gus has agreed to stay one more year as secretary because next year we will elect secretary. Working in moving forward in agreement.

 Julian Stann another suggestion. If you want to suggestion someone else type it in Armando Cervantes- can touch a lot of topics on Kerygma. Will see availability and narrow it down.
- Teresa –The meeting will be at the Corpus Christie Liturgical Retreat Center. They are very excited to be hosting, all spaces have been booked. Strategic team has talked about large chapel will have mass, also small chapel for individual prayer set up and sending out registration October 10th. Sent pricing and they are working on lowering the cost, and working on providing hospitality, hoping to take the group out on the Bayfront. Hoping to be able to get a view of CC with everyone.

Cost single room \$75.00 per night and meals over \$200. For single for double room somewhere in proximately of \$128.00 or \$132 for double so we reserved 20 double rooms and 10 single rooms. They're very excited to host everyone. 16 miles north of CC, not in city about 15 to 20 mins from airport. Will have all information at a later day. Discussion of flights. Dates January 22nd, 23rd and 24th. Wed will have boxed lunches.

Discussion of a Texas PCL Rep for NCCL - Brian Garcia-Luense

Position and History – Major governing bodies is representative council which is the most broad based constancy based part of the governing body of NCCL. Serves as the important consultative role of the board of directors and is the body that elects the at large members of the board of directors. And according to NCCL by laws, every ecclesiastic's providence in the US is eligible to send both dioceses representative and a parish catechetical leader to the representative council. In my knowledge there has never been a PCL representative for either of the provinces in TX. Three things are necessary in order for someone to be able to serve in that role:

1) They do have to be a Professional Member of NCCL

2) They have to meet professional qualification, master degree or PCL certification recognized by USCCB.

3) They need legitimacy recognition mandate by the PCLs of the province, i.e. some sort of gathering in person, virtual or some sort of PCL organization that has a province wide representation.

The only other challenge we have is funding, the person would need to be able to attend and fund the meeting. They meet twice a year once in conjunction with the regular annual meeting of the conference, so not much additional expense involved in that. But the other one is usually in late Oct or early Nov and is often in Chicago or Dallas.

Question: How do we fund our Diocese rep to go at this point?

Answer: Funded by TCCB as a part of their budget. In the past it was always funded by the TX Catholic Conference and Bishops. Trying to make sure that that continues. When Margaret McGetrick was the rep for both our committee and general education committee for Catholic school, she would figure out how to find the funding to cover the cost of the person going and apparently that was not the norm of what was happened. She made it possible to guarantee a person was going, with some funding to offset the cost for us. We ask Catholic Conference and Bishops, is to consider having some kind of means of that.

Julie - A Budget was submitted but haven't gotten an answer back. Discussion of who to contact, who's responsible for responding. Difficult in getting response.

In Minnesota there was 2 institutes—Minnesota Catholic Education Association, a leadership forum that was connected to that represented by all the Dioceses in Minnesota. We dealt with Bishops agenda re: Evangelization, catechists, catholic schools, etc. We had another organization that included the Dakotas because it was part of our region and it was independent of the Bishop itself. So we had annual fees that went into this so that they could afford to send a rep.

There hasn't been a problem in the past with getting a rep, so I think the test has always been when we submit the bill. Having had a PCL rep. Someone from Galveston/Houston approached us with wanting to be the PCL rep. That's what brought this up, second question is how we get that in the budget. We just have to pursue that to find out how we put that in the budget and if there exists a budget for this group. In the meantime what do we do with the person who raised their hand and said I would be willing to accept that responsibility? Brian seems to think they would have to be nominated. Ask all PCLs if they want to be nominated from each diocese then put ballot together. Must be NCCL members, and there's other credential that you have to look at. Suggested sending out list of PCL that want to be on the list. Email will be sent out, with time frame to submit responses. The diocesan website has not connected to NCCL website. Gus will find out if budget is approved. Put together an email to send to If interested and qualification of being rep and

Expectations/benefits of having a TCC Rep attend the Representative Council Meeting

NCCL is a member driven organization, and the Representative Council is an important vehicle for setting the goals of the organization. In the past the persons representing the dioceses of Texas have had a great influence upon catechesis in our nation. Just one important example is that the dioceses of the Texas Province were the first ones to lobby for publishers to create bilingual materials for catechesis, and as a result NCCL took up this cause with its publishing partners/members. It is expected that a province representative brings the experience and needs of their provincial dioceses to NCCL. Catholic life in Texas is different than in other parts of the country, and our voice is needed to assure that NCCL, as the national voice of catechesis, really speaks for and responds to the needs of the reality of catechesis in the Texas.
